NOTICE OF CIVIL VIOLATION AND PENALTY IMPOSED

NOTICE IS HEREBY GIVEN that you have incurred, and there is now due and payable from you, a penalty in the amount of \$ 100.00 under the provisions of ACC 1.12.040(e).

On **July 11, 1998** you received an Order to Correct Violation, which required you to correct your sewer and to complete said actions no later than **July 25, 1998**. A review of the records for evealed that the order to correct violations has not been complied with. ACC 1.12.040 (b)(1) provides that if the required correction has not been completed by the correction date or time as specified in the order to correct violation, the Department may issue a notice of civil violation to each person to whom an order to correct violation was directed.

In view of the foregoing and in accordance with the provisions of ACC Title 13 and ACC 1.12.040.

employee or agent shall, upon receipt of this order, immediately cease from the aforementioned violations. Failure to comply with this order shall result in further penalties upon the interest in the amount of \$100.00 for each and every day that you continue to conduct activities in violation of ACC Title 13.

IT IS FURTHER ORDERED THAT will take appropriate action in accordance with the following instructions:

- 1. Obtain permit from Public Works Department, second floor of Aberdeen City Hall (The permit fee will be waived upon presentation of this letter when obtaining the permit.)
- Repair building sewer at point of smoke leak and have such repair visually inspected by the City Sewer Inspector.
- 3. Repairs shall pass City Sewer Department smoke test.

FAILURE TO COMPLY WITH THE TERMS OF THIS ORDER AND TO PAY THE PENALTY IMPOSED WILL RESULT IN FURTHER ACTION BY THE CITY, INCLUDING, BUT NOT LIMITED TO, IMPOSITION OF ADDITIONAL CIVIL PENALTIES OF UP TO \$500.00 PER DAY, ABATEMENT PROCEEDINGS, AND ENFORCEMENT ACTIONS IN SUPERIOR COURT.

The penalty herein described must be paid to the City Clerk within seven (7) calendar days from the receipt of this order. Remission of the penalties imposed by this order may be sought from the City of Aberdeen Board of Adjustment by filing a notice of appeal with the City Sewer Department within seven (7) calendar days of your receipt of this order, as provided in ACC 1.26.050. You cannot appeal the amount of the monetary penalty imposed. You will be provided with notice of a hearing before the Board, at which time the Board will review the Department's determination that a violation occurred and will either cancel the penalty or allow it to remain as originally stated. Any monetary penalty assessed must be paid to the City Clerk within seven (7) calendar days of the Board's decision should your appeal be denied.
