# Keeping the Bay Clean and Healthy— New Regulations Will Be Challenging

California State Water he Resources Control Board (Board), with oversight from the U.S. Environmental Protection Agency (EPA), is responsible for regulating the quality of water and treated wastewater released into the San Francisco Bay. Permits that the Board issues for treatment plants require that the agencies operating the plants meet stringent local, state and federal requirements. Meeting these requirements has become increasingly difficult and the State Board is tightening those regulations again. Specifically, the future operation of the East Bay Municipal Utility District's (EBMUD) wet weather treatment facilities will not be allowed.

The EBMUD Pt. Isabel wet weather treatment plant was constructed in the early 1990s and was part of a cost-effective program, which resulted from the East Bay Inflow/Infiltration Study in the 1980s approved by the Board and EPA. The amount of wastewater coming into the Pt. Isabel plant in heavy rainstorms can swell to 50 million gallons a day, considerably more than the typical dry weather peak flows of about 5 million gallons a day. The plant holds and treats this excess volume from Stege, Albany and North Berkeley during storms. When the incoming flow is reduced, the surplus wastewater is pumped to the EBMUD treatment plant in Oakland, at the foot of the Bay Bridge. During

extremely high flow periods, the Pt. Isabel plant must discharge some of the treated wastewater to the Bay instead of pumping it to the Oakland facility for additional treatment.

A blue ribbon panel consisting of environmental groups, EPA staff, Regional Water Board staff, technical experts and community groups has been put together to review the challenge of meeting these tough, new regulations. The panel is truly a cross-section of the community that is reviewing EBMUD's alternatives and studies that are underway in order to identify their selected actions.

Property owners are responsible for their laterals, including any section that is located under the public right-of-way or streets. Defective laterals can cause up to 75% of extra water in the system. At present, a Certificate of Compliance verifying good condition of a lateral is required when a property or home is sold, but the condition of a lateral at any time is the responsibility of the property owner.

The final plan for meeting the Board and EPA requirements will no doubt involve more than one approach and will involve a collaborative effort. It may be necessary to build storage facilities, expand existing treatment facilities, and accelerate the lateral testing and replacement program. It is very likely there will be major, significant additional expenses involved with the combination of approaches to address the new permits and regulations. Stege remains committed to spending funds in the most cost-efficient manner possible, although it will be challenge to minimize costs to meet the evolving, yet-tobe defined requirements.


# **Stege Wins CSRMA Award**

or the fifth year in a row, the Stege Sanitary District has won the prestigious California Sanitation Risk Management Authority's (CSRMA) Best Performance Award for its record of having over ten years in which there were no on-the-job accidents, no time lost to accidents, and no workman compensation claims.

The CSRMA is a pool of 58 sanitary districts throughout California who have joined together to provide insurance for its member agencies. The organization employs a full-time loss-control specialist who conducts on-site safety evaluations and regional safety training seminars.

By taking a proactive approach to ensuring the wellbeing of its employees and by joining economic resources, CSRMA-member agencies significantly reduce their insurance expenditures while providing a workplace that is safe and operating in accordance with all local, state, and federal regulations.

Stege owes its extraordinary safety record to its staff of ten employees who are dedicated to their job and to the community they serve.

# **Proper Disposal of Medicines**

ou know you shouldn't keep medicines past their expiration dates, but what should you do with them? Flushing expired or unwanted medicines down the

toilet might seem to be the logical choice. Unfortunately, flushing drugs down the drain may harm San Francisco Bay.

Wastewater treatment cannot remove all medicine and dangerous amounts of chemicals can find their way back into our

water system. There is, however, a safe and convenient way to dispose of these items: The West Contra Costa Integrated Waste Management Authority Household Hazardous Waste Facility located 1,000 feet east of the Richmond Parkway at 101 Pittsburg Avenue in Richmond. West County residents can properly dispose of household hazardous waste, including unwanted prescription and over-the-counter medicines

(pills, syrups and inhalers) plus "medical sharps" (needles, syringes and lancets) in approved containers, at the drive-through

drop-off center for NO CHARGE. Medicines must be in their original containers and controlled substances are not

accepted. Proof of residency is required and Kensington residents must obtain a permit from Bayview Refuse and Recycling at (510) 237-4614 before using the facility.

Household Hazardous Waste Facility hours are 9:00 am-4:00 pm Thursday and Friday and 9:00 am-4:00 pm the first Saturday of each month. The facility is closed from 12:00-12:30 pm for lunch. Call (888) 412-9277 for information.

#### **SAFER ALTERNATIVES**
